Tourist accomodation – Conditions

1 – Rental contract – date of effect (following the rules set out in the Code Civil)

Reservation ensures accommodation for a defined period of stay in a chalet or other types of rented accommodation situated on the campsite . The client is hereafter termed « the Tourist ».

A rental contract form must be carefully completed and returned by the Tourist to the campsite. We will confirm your booking and return the contract to you within a week.

In no circumstances can the person renting accommodation sub-let or pass the rental over to a third party.

The rental contract implies acceptance of the campsite regulations, which the Tourist shall sign on site on arrival.

2 – Reservation

The money payable on reservation consists of the deposit and a non-returnable booking fee. If the reservation is cancelled, the Tourist will forfeit the deposit.

3 – Payment of the balance

The price of the stay indicated on the rental contract represents the total cost of services provided. The balance (total amount less deposit) is payable at the start of the contract, that is to say on arrival at the site.

4 – Cancellation

Cancellation less than four weeks before the date of arrival will result in a compensation payment equal to the total cost of the stay, payable by the person who cancels.

5 – Interrupted stay

The Tourist will not be reimbursed for any time or services not used, regardless of reason for the non-completion of the stay.

6 – Availability of accommodation

The rented accommodation will be available to the Tourist from 4 pm on the day of arrival. It must be vacated before 10 am on the day of departure. The identification number (s) will be determined by « Le Val de la Marquise » campsite on arrival day.

The accommodation should be left as it was found.

The inventory will be given to the Tourist on arrival. Any anomalies must be notified to and rectified by the site management the same day.

7 – Site regulations : noise and disturbances

Tourists must comply with the regulations which are on display at reception.

Reminder :

Any behaviour liable to cause harm to others is forbidden.

Circulation of vehicles on site is forbidden between 11 pm and 8 am ; vehicles can be left in the car-pack at the entrance.

In the bathing areas (unsupervised) : French hygiene regulations prohibit men's swimming shorts or Bermudas ; only classic swimming trunks are allowed.

Domestic animals are accepted, on condition that they do not annoy other campers. They must not be let off the leash, or shut up anywhere. They must be taken off the campsite to urinate or defecate. They must comply with the relevant veterinary services regulations.

Visitors must pass through Reception, pay the relevant sum and comply with the campsite rules. They should leave their car at the entrance to the site. The access to the swimming-pool is forbidden for visitors.

Please help us to keep the campsite pleasant and clean – put all waste and rubbish in the dustbins provided.

8 – Refundable deposit

On arrival, the Tourist will be asked for a deposit as a guarantee. This deposit will be handed back after the inventory has been checked on departure day, and after deduction, if necessary, of the cost of breakages or repairs incurred in rectifying the state of the accommodation.

9 – Insurance

Tourists should have civil liability insurance cover for any damage they might cause. If you wish, you can take out insurance to cover the cost of cancellation due to serious and justifiable causes, before or during your stay.
